Use Form 540-ES, Estimated Tax for Individuals, and the 2014 CA Estimated Tax Worksheet, to determine if you owe estimated tax for 2014 and to figure the required amounts. Estimated tax is the tax you expect to owe in 2014 after subtracting the credits you plan to take and tax you expect to have withheld. If you need to make a payment for your 2013 tax liability or make a separate payment.

INSTRUCTIONS FOR 2014 PIT-ES, ESTIMATED TAX PAYMENT VOUCHER

Calendar-year taxpayers: The first estimated payment due for tax year 2015 is April 15, 2015. The next payments are due June 15, 2015; September 15, 2015; and January 15, 2016.
