Three-Day Notice to Pay Rent or Quit As soon as a tenant fails to pay rent, a landlord can give the tenant a three-day notice. This notice must inform the tenant that if the tenant does not pay rent within three days of receiving the notice, then the landlord will begin eviction proceedings against the tenant (see Cal. Code of Civ. Proc. 1161(2)).

**Free Three (3) Day Eviction Notice to Pay or Quit - PDF ...**

The 3-day eviction notice template is used by landlords to inform a tenant that they are in violation of their lease agreement. The document may be given for any type of infraction, most commonly being the non-payment of their rent, but could be for any type of non-compliance such as sound complaints, damage to the premises, pets on the property, occupancy by guests, and any other types.

**What Is a 3-Day Notice to Pay Rent or Quit in California ...**

A 3-day notice to pay rent or quit should not include any money the tenant owes other than the rent. This means no extras should be added on such as late fees, interest or damages. The notice also has to be very specific as to when the money is due, stating it must be paid within 3 days of the notice or the tenant must vacate the premises.

WITHIN THREE (3) DAYS after service on you of this notice, you are hereby required to pay the amount of the above stated rent in full OR quit the subject premises, move out, and deliver up possession to the owner and/or his authorized agent.
